GOAL I: INCREASE ORGANIZATIONAL CAPACITY TO SUPPORT GROWTH, AGILITY, AND IMPACT.

Scenic Rivers has met the highest standards of accreditation, creating a solid foundation for us to accelerate the pace of land conservation, increase stewardship, and ensure organizational longevity. By increasing our capacity, including staffing, reserves, endowments, outreach, and communications, we will be more agile, increase our impact, and reach more communities.

To support this goal, we will:

- 1. Diversify and increase sources of funding to fully fund programs and ensure long-term financial health.
- 2. Raise the visibility and awareness of Scenic Rivers through a wellresourced and targeted communication and outreach plan.
- 3. Increase staffing to meet evolving needs of the organization.
- 4. Maintain effectiveness and efficiency of the easement monitoring program.







GOAL 2: ACCELERATE LAND CONSERVATION IN THE COUNTY THROUGH EQUITABLE AND VARIED MEANS.

To reach the state's 40x40 goal, the county's green infrastructure goals, and our own aspirations of conserving our Top 100 properties, we need to conserve land at a faster pace. To increase the speed of conservation and include more communities, we will expand our conservation toolset, such as fee simple acquisitions. Land conservation is intertwined with the development pattern of the county. Unsustainable development patterns guarantee more lands are lost at a faster rate. To have thriving communities, we need conserved lands adjoining a connected network of multi-modal transportation and thoughtfully planned development that allows people of all income levels to access nature, transportation, housing, and employment. We will join land conservation organizations around the state to promote policies that enable and encourage sustainable growth patterns.

To support this goal, we will:

- 1. Collaborate with partners and funders to use a variety of tools to conserve Scenic Rivers' Top 100 Properties and other critical properties, some of which are accessible to the public.
- 2. Engage with under-represented and under-resourced communities to meet their conservation needs, beginning with North County. Work with these communities to implement creative conservation solutions such as community gardens or pocket parks.
- 3. Encourage equitable and sustainable growth policies at a local, state, and systems level.







GOAL 3: PROMOTE AND ADVANCE FOREST HEALTH ON CONSERVED LANDS.

Beyond annual monitoring, conserved lands now need a higher level of human care. The method of "preserve and forget" rarely works anymore. Invasive species, especially invasive plants, are a growing problem that could unravel our 35 years of work if left unchecked. Invasive plant control is among the most essential actions we can take to care for our conserved lands. Our Healthy Forests Program is growing steadily, and we will continue to build on its momentum by increasing funding and volunteer participation to protect forest biodiversity and engage the public.



To support this goal, we will:

- Strengthen the resilience of the Bacon Ridge Natural Area through increased funding for the Healthy Forests Program, including funds for contractors, supplies, and staff capacity to engage and educate volunteers.
- 2. Expand our Healthy Forests Program to other conserved properties.
- 3. Collaborate with partners to support policies and initiatives to remove invasive species across the landscape.
